

# Petition for Academic Reinstatement

This form is for students academically dismissed from Western Washington University (WWU) to petition for reinstatement. Students should meet with an advisor at least twice, soon after dismissal plus right before submitting their petition. WWU recommends that students take at least two quarters away to complete courses at other institutions or through WWU's Outreach and Continuing Education. Students will need to earn strong grades in transferable courses to demonstrate their academic readiness to return.

1. Personal Statement
2. Official Transcripts for all coursework since dismissal
